

Pre-Release Software End User License Agreement

Intending to be legally bound by this Pre-Release Software End User License Agreement ("Agreement"), you ("Licensee") and Unisys Corporation ("Unisys") agree the following terms will apply to Licensee's use of the Software lawfully obtained by Licensee from Unisys and any documentation related thereto. This Agreement, including any license plan descriptions and any separate license agreements applicable to the Software either supplied with the Software or published at <http://public.support.unisys.com/common/ShowWebPage.aspx?id=6316&pla=ps&nav=ps> ("License Plans"), is the entire agreement between the parties for the Software and supersedes all prior written or oral communications between the parties, including any preprinted terms which may appear on a purchase order. If you are entering into this Agreement on behalf of an entity, such as your employer, you represent that you have the legal authority to bind that entity. If you specify a company name in connection with the Software download, you will be deemed to have entered into this Agreement on behalf of that organization or company. **By copying, installing, or using all or any portion of the Software, Licensee accepts the terms and conditions of this Agreement.** IF YOU DO NOT ACCEPT THESE TERMS, YOU MAY NOT DOWNLOAD, COPY, INSTALL OR USE THE SOFTWARE. DOWNLOADING, COPYING, INSTALLATION, OR USE OF THE SOFTWARE CONSTITUTES ACCEPTANCE OF THESE TERMS.

NOTICE

THE SOFTWARE IS PRERELEASE SOFTWARE OF PRE-PRODUCTION QUALITY. IT MAY NOT BE STABLE OR TESTED TO THE SAME LEVEL AS COMMERCIALY RELEASED SOFTWARE AND MAY CONTAIN CODING, DESIGN OR OTHER DEFECTS. LICENSEE BEARS THE RISK OF USING THE SOFTWARE. IN NO EVENT WILL UNISYS BE LIABLE FOR LOSS OR DAMAGE TO LICENSEE'S DATA FROM ANY CAUSE. LICENSEE SHALL HAVE THE SOLE RESPONSIBILITY FOR ADEQUATE PROTECTION OF ITS DATA USED IN CONNECTION WITH THE SOFTWARE. THE SOFTWARE MAY CHANGE BEFORE COMMERCIAL RELEASE OR MAY NOT BE RELEASED AS A PRODUCT OR SUPPORTED. Licensee may not (i) use the Software in a production environment; (ii) disclose the results of any test or evaluation of the Software to any third party without Unisys' written approval except as provided in this Agreement; and (iii) attempt to circumvent technical protection measures in the Software, reverse engineer, decompile or disassemble the Software, except if the laws where Licensee's principal place of business is located permit this even if the Agreement does not. Licensee may provide reports, code, content, comments, feedback, suggestions, information, or other materials relative to the Software ("Feedback"). All Feedback shall be the exclusive property of Unisys and be kept confidential by Licensee. By providing Feedback, Licensee is irrevocably granting Unisys and its affiliated companies free of any charge the right to make, use, distribute, and otherwise commercialize the Feedback in any way and for any purpose. In addition, Unisys shall have the sole and exclusive right to register copyright of any Feedback in its own name in any and all countries and to obtain renewals thereof and to manufacture, reproduce, publish, distribute, and sell such Feedback. All right, title, and interest in and an improvement of the Software, whether or not patentable, conceived or made in the course of, or as a result of performance under this Agreement, shall be the exclusive property of Unisys; and Licensee agrees to cooperate with Unisys, at Unisys expense, in the execution and filing of documents relating to United States and foreign patent applications on behalf of Unisys and in the worldwide assignment of the same in favor of Unisys. The rights under this section will survive termination of this Agreement.

1. Definitions

1.1 "**Confidential Information**" is all information and materials provided or disclosed by Unisys to Licensee under this Agreement, including without limitation, (i) the Software and its documentation in any form, (ii) any technical or business information relating to the Software, including its release, pricing, features, functionalities, performance, testing, error reports, and diagnostics, (iii) any other information and materials relating to Unisys, its products, clients or business, and (iv) feedback on the Software supplied by Licensee.

1.2 "**Evaluation Period**" starts upon Unisys delivery of Access Credentials (as defined below) to permit access to or download of the Software by Licensee and ends one year later unless a shorter period is set in the Access Credentials or the license is earlier terminated according to this Agreement.

1.3 "**Software**" is the object code version of computer programs, image enabler, license or performance key, source code version that Unisys may provide, and any documentation related thereto, excluding maintenance materials. Software includes microcode that is not permanently fixed in equipment.

2. License

2.1 Unisys either licenses Software directly or distributes Software. In either case, Licensee does not obtain ownership of Software. If Unisys licenses or distributes any Software pursuant to a separate license agreement such license agreement shall apply to that Software except that the license is only valid for the Evaluation Period notwithstanding any contrary term in the License Plan(s). License Plans shall be read to add additional conditions or restrictions to this Agreement, and any more restrictive terms in this Agreement shall control in the event of any conflict, except in the case of Software licensed under an open source license agreement, nothing in this Agreement shall be read to add additional conditions or restrictions, or affect any rights and/or obligations Licensee may have, pursuant to any such open source license.

Otherwise, the following license terms will apply:

2.2 Licenses begin upon Unisys' shipment of the Software to Licensee or when the Software is made available to Licensee for download. The Software is licensed for the Evaluation Period only and for purposes of evaluating whether the Software meets Licensee's needs. UNISYS LICENSES EACH COPY OF THE SOFTWARE AND DOCUMENTATION TO LICENSEE ON A PERSONAL, NON-EXCLUSIVE AND NON-TRANSFERABLE BASIS FOR LICENSEE'S NON PRODUCTION INTERNAL USE BUT NOT AS A SERVICE BUREAU, NOR FOR OUTSOURCING, NOR FOR FACILITIES MANAGEMENT.

2.3 LICENSEE SHALL NOT, NOR SHALL LICENSEE ENCOURAGE OR PERMIT OTHERS TO COPY SOFTWARE OR DOCUMENTATION EXCEPT FOR A REASONABLE NUMBER OF COPIES NECESSARY TO EXERCISE THE RIGHTS GRANTED, WHICH MUST BEAR ALL THE LEGENDS AND NOTICES OF THE ORIGINAL ITEM.

2.4 LICENSEE SHALL NOT, NOR SHALL LICENSEE ENCOURAGE OR PERMIT OTHERS TO ALTER, REMOVE, OR OBSCURE ANY PROPRIETARY LEGEND, COPYRIGHT, TRADEMARK, PATENT OR OTHER PROPRIETARY INTELLECTUAL PROPERTY NOTICE CONTAINED IN OR ON THE SOFTWARE OR DOCUMENTATION.

2.5 LICENSEE SHALL NOT, NOR SHALL LICENSEE ENCOURAGE OR PERMIT OTHERS TO INTERFERE WITH OR ALTER ANY INITIALIZATION SYSTEM, ENCRYPTION TECHNIQUES, OR LICENSE AUTHENTICATION TECHNIQUES.

2.6 Licensee will not create, copy, deduce or attempt to create, copy, deduce (by reverse engineering, disassembling or otherwise) the source code, internal structure, design architecture, or organization of the Software, except and only to the extent expressly permitted by applicable law.

2.7 LICENSEE MAY NOT USE THE SOFTWARE IN CONNECTION WITH ANY SYSTEM WHERE MALFUNCTION CAN REASONABLY BE EXPECTED TO RESULT IN PERSONAL INJURY, DEATH, OR DAMAGE TO TANGIBLE PROPERTY OR TO THE ENVIRONMENT. WITHOUT LIMITING THE FOREGOING, THE SOFTWARE SHALL NOT BE USED IN CONNECTION WITH ANY LIFE SUPPORT OR PATIENT CARE SYSTEM, NUCLEAR FACILITY, AIRCRAFT OPERATION, AIR TRAFFIC CONTROL, OR OTHER APPLICATION REPRESENTING A SIMILAR DEGREE OF HAZARD. LICENSEE AGREES TO INDEMNIFY, DEFEND AND HOLD HARMLESS UNISYS AND ITS OFFICERS, DIRECTORS, EMPLOYEES, AND AFFILIATES FROM ANY CLAIMS OR LOSSES RESULTING FROM ANY OF THE FOREGOING USES OF THE SOFTWARE.

2.8 NO LICENSE IS GRANTED TO LICENSEE TO USE THE SOFTWARE TO ASSESS, TEST, OR DEVELOP ANY HARDWARE PRODUCTS OR DEVICE HANDLER SOFTWARE, OPERATING SYSTEM SOFTWARE OR HARDWARE DIAGNOSTIC SOFTWARE. LICENSEE MAY DEVELOP OTHER SOFTWARE PROGRAMS AND MAY TEST FULLY-DEVELOPED, COMMERCIALY-AVAILABLE THIRD PARTY HARDWARE PRODUCTS OR SOFTWARE PROGRAMS WHERE SUCH TESTING IS SOLELY INTENDED FOR LICENSEE'S INTERNAL EVALUATION OF THE FITNESS OF SUCH PRODUCT OR PROGRAM FOR LICENSEE'S OWN INTERNAL BUSINESS PURPOSES.

2.9 UNISYS MAY REQUIRE LICENSEE TO UPDATE THE SOFTWARE AND LICENSEE SHALL REPLACE THE SOFTWARE WITH THE COPY CONTAINING THE UPDATES UPON RECEIPT. ANY UPDATES PROVIDED BY UNISYS SHALL BE DEEMED SOFTWARE UNDER THIS AGREEMENT.

2.10 UPON NOTICE TO LICENSEE, UNISYS MAY AUDIT LICENSEE'S USE OF THE SOFTWARE TO DETERMINE LICENSEE'S COMPLIANCE WITH THIS LICENSE PROVIDED UNISYS COMPLIES WITH LICENSEE'S CUSTOMARY SECURITY RULES AND DOES NOT UNREASONABLY INTERFERE WITH LICENSEE'S PERMITTED USE, AND IN SUCH EVENT, LICENSEE AGREES TO PROVIDE RELEVANT INFORMATION AND REASONABLE ACCESS TO FACILITIES.

2.11 THE SOFTWARE AND ANY ACCOMPANYING DOCUMENTATION ARE COMMERCIAL ITEMS THAT HAVE BEEN DEVELOPED ENTIRELY AT PRIVATE EXPENSE. THEY ARE DELIVERED AND LICENSED AS COMMERCIAL COMPUTER SOFTWARE AND COMMERCIAL SOFTWARE DOCUMENTATION WITHIN THE MEANING OF THE APPLICABLE ACQUISITION REGULATION(S). THE LICENSE CONTAINED IN THIS AGREEMENT PRESCRIBES EXCLUSIVELY THE GOVERNMENT'S USE AND DISCLOSURE OF THE SOFTWARE AND DOCUMENTATION.

2.12 Unisys reserves all rights not expressly granted.

3. No Warranties. Licensee acknowledges that the Software are of pre-production quality, and may be incomplete, contain coding, design or other defects. THE SOFTWARE IS PROVIDED "AS IS", "WITH ALL FAULTS" AND WITHOUT WARRANTY OR SUPPORT OF ANY KIND, WHETHER EXPRESS OR IMPLIED. TO THE FULLEST EXTENT PERMISSIBLE UNDER APPLICABLE LAW, UNISYS DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, TITLE, OR NON-INFRINGEMENT. UNISYS DOES NOT REPRESENT OR WARRANT THAT THE SOFTWARE WILL MEET LICENSEE'S REQUIREMENTS, OPERATE UNINTERRUPTED OR IS ERROR FREE, THAT DEFECTS IN THE SOFTWARE WILL BE CORRECTED, OR THAT THE SOFTWARE, ANY CONTENT ACCESSED BY THE SOFTWARE, AND/OR ANY SITES THAT SUPPORT THE SOFTWARE ARE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS. UNISYS DOES NOT ACCEPT ANY LIABILITY FOR FAILURE TO PROVIDE NOTIFICATION OF ANY OR ALL DEFECTS IN THE SOFTWARE. UNISYS DOES NOT MAKE ANY WARRANTIES OR REPRESENTATIONS REGARDING THE USE OF THE SOFTWARE IN TERMS OF COMPETENCE, CORRECTNESS, ACCURACY, ADEQUACY, USEFULNESS, TIMELINESS, RELIABILITY, OR OTHERWISE. LICENSEE AT THE REQUEST OF UNISYS WILL, OR AT ITS OWN ELECTION MAY, RETURN ANY SOFTWARE TO UNISYS THAT HAS, OR IN UNISYS DETERMINATION IS LIKELY TO, BECOME SUBJECT TO A CLAIM OF INFRINGEMENT AND THIS AGREEMENT WILL TERMINATE FOR THAT PRODUCT UPON RECEIPT BY UNISYS. UNISYS IS NOT OBLIGATED TO DEVELOP A FINAL COMMERCIAL VERSION OF THE SOFTWARE NOR DOES IT WARRANT IN ANY WAY THAT THE SOFTWARE WILL BE RELEASED AS A PRODUCT OR SUPPORTED. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF WARRANTIES, SO SOME OR ALL OF THE FOREGOING EXCLUSIONS MAY NOT BE APPLICABLE TO LICENSEE. IN THE EVENT A PARTICULAR EXCLUSION IS FOUND TO BE UNENFORCEABLE, LICENSEE AGREES THAT THE REMAINING EXCLUSIONS SHALL STILL APPLY.

4. Limitation of Liability

A) LICENSEE'S SOLE AND EXCLUSIVE REMEDIES FOR DAMAGES FROM ANY CAUSE RELATED TO OR ARISING OUT OF THIS AGREEMENT REGARDLESS OF THE LEGAL THEORY, WHETHER BASED ON NEGLIGENCE, BREACH OF CONTRACT, WARRANTY OR OTHER LEGAL THEORY, WILL BE THOSE PROVIDED IN THIS AGREEMENT.

(B) TO THE GREATEST EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL UNISYS OR ITS SUPPLIERS AND SUBCONTRACTORS BE LIABLE FOR: (1) ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, PUNITIVE, OR CONSEQUENTIAL DAMAGES, (2) LOST PROFITS OR LOSS OF REVENUE (WHETHER DIRECT OR INDIRECT), (3) LOSS OF USE OR DAMAGE TO OR LOSS OF DATA, (4) LOSS OF GOODWILL OR OTHER DIMINUTION IN THE VALUE OF LICENSEE'S BUSINESS, OR (E) CLAIMS AGAINST LICENSEE FROM OTHERS, IN ALL CASES EVEN IF KNOWN OR FORESEEABLE. IN ANY EVENT, UNISYS AND ITS SUPPLIERS AND SUBCONTRACTORS MAXIMUM AGGREGATE LIABILITY ARISING UNDER THIS AGREEMENT WILL NOT EXCEED \$250.00. LICENSEE SHALL HAVE THE SOLE RESPONSIBILITY FOR ADEQUATE PROTECTION OF ITS DATA USED IN CONNECTION WITH THE PRODUCTS.

5. Confidential Information

5.1 Licensee acknowledges that all or part of Confidential Information is a highly valuable trade secret of Unisys and agrees not to misuse this confidential information, e.g., by using it to create a competitive product.

5.2 Licensee shall not disclose Confidential Information except to (i) its employees who have a need to know and are involved in the evaluation and testing of the Software and or (ii) the other members of the Unisys user community for the Software if Unisys provides access to such community to Licensee as a forum to share Feedback. Licensee shall use Confidential Information solely for purpose of performance under this Agreement. Licensee will use the same measures it uses for its own information of a similar nature, but not less than reasonable measures, to protect Confidential Information from unauthorized use or disclosure and to restrict its use according to this Agreement. Title or the right to possess Confidential Information will remain with Unisys. Unisys disclaims any liability relative to Licensee's personal data which may be entered into, accessed by, stored in, or otherwise used by the Software.

5.3 The obligations stated in this Section do not apply to Confidential Information: (a) already known to the recipient at the time of disclosure; (b) independently generated by the recipient and not derived from the Confidential Information supplied by the disclosing party; (c) publicly known or available, except where such knowledge or availability is the result of unauthorized disclosure by the recipient of the Confidential Information; (d) rightfully disclosed to the recipient without a similar restriction by a third party; or (e) required to be disclosed by the recipient by law, regulation, court order, or other legal process, provided the recipient provides, to the extent possible, reasonable advance notice to the other party of such disclosure. When this Agreement ends, or upon request, the recipient agrees to return or destroy Confidential Information received under this Agreement, including all copies made, and all writings, descriptions and summaries involving or based on such Confidential Information. These confidentiality obligations shall continue after this Agreement ends.

5.4 If access to the Software or Unisys' systems or networks is provided to Licensee, any and all information made available for such access shall be considered Unisys Confidential Information and Licensee shall (i) direct personnel not to attempt to break security systems or to obtain access to any programs or data beyond the scope of the access rights granted and not to conduct any activity using issued login-ids, passwords, keys or other access credentials ("Access Credentials") contrary to applicable laws and regulations, including without limitation those relating to export and import laws, and the terms of use embedded into the systems and network; and (ii) if access has been granted to named individuals through the issuance of Access Credentials, restrict access to such individuals, direct them not to share or transfer Access Credentials with anyone, and immediately notify Unisys if an individual authorized to access the systems and network is no longer an employee or no longer requires access to the systems and networks. Without limiting any of its other rights, Unisys reserves the right to restrict, monitor and/or terminate access to the Software, its systems and network at any time.

6. Dispute Resolution. Any claim or controversy relating to or arising out of this Agreement, whether in contract, in tort or otherwise, will be resolved on a confidential basis under the commercial mediation and arbitration rules of the American Arbitration Association according to the following process, by first delivering a written notice describing the dispute and the amount involved ("demand") to the other party: (a) **Mediation** - After receipt of a demand, either party may start mandatory non-binding mediation before a single mediator; (b) **Arbitration** - If the dispute remains unresolved 45 days after the receipt of the demand, either party may start binding arbitration before a single arbitrator. No statements by, or communications between, the parties during negotiation or mediation, or both, will be admissible for any purpose in arbitration. The arbitrator will have no authority to award punitive damages, and its decision must be consistent with this Agreement. Each party will pay its own expenses and attorney's fees. Either party may use a court of competent jurisdiction to (a) enforce an arbitration award; (b) seek temporary equitable relief to protect its interests; or (c) recover specific property, including an action in replevin. No action arising out of or relating to this Agreement may be brought more than 2 years after the cause of action first accrued, except if a demand is made within 45 days before the end of this 2 year period, the parties shall have an additional 60 days from the demand to start mediation under this Agreement.

7. Termination and Cancellation. The license for the Software automatically terminates at the end of the Evaluation Period. Licensee may terminate this Agreement at any time by uninstalling and deleting all copies of the Software. Unisys may terminate this Agreement and repossess the Software at any time upon written notice. When this Agreement terminates or expires, or upon request, Licensee shall return promptly or destroy (and certify in writing destruction of) any tangible, intangible, and machine-readable forms of the Software and any other Confidential Information furnished in connection with the Agreement, including all copies made, and all writings, descriptions and summaries involving or based on such Confidential Information.

8. Other Provisions. Licensee and Unisys will tell their agents and employees of their obligations under this Agreement. Neither party will be liable to fulfill its obligations when due to causes beyond its reasonable control, excluding payment of monies due. Any failure or delay by either party in exercising any right or remedy will not be a waiver. Each provision of this Agreement is severable. **THE LOCAL LAW OF THE COMMONWEALTH OF PENNSYLVANIA WILL GOVERN THIS AGREEMENT, WITHOUT REGARD TO CONFLICTS OF LAWS PROVISIONS.** This Agreement may only be modified by a writing signed by a duly authorized representative of Unisys. Licensee may not assign or transfer Licensee's rights or obligations under this Agreement without the prior written consent of Unisys. Licensee will comply with all applicable import and export laws and regulations.
